### Passport Turkey

#### Additional information:

If it appears from the documents of a non-Turkish passenger that their original nationality was Turkish, the passenger may have obtained his new nationality without special consent of the Turkish government. In that case, the authorities in Turkey will consider the passenger to be a national of Turkey. Such passengers are advised to make enquiries about possible consequences before arrival in Turkey.

Nationals of Ukraine will not be allowed to enter Turkey if they have previously been deported.

Passengers holding travel documents printed in their own language and not in the Latin alphabet will be refused entry and deported.

#### The following warning(s) apply to passports and other travel documents:

Passports and all other travel documents in booklet form of all non-Turkish nationals must contain at least 1 unused visa page . Please note that this does not include the page reserved for "Observations" or "Amendments and Endorsements".

### Visa Turkey

#### The following should be taken into account even if holding a Visa:

Visitors who require a visa, must also hold proof of hotel reservation and documents for their next destination .

Nationals of the following countries are required to hold:

- USD 300.- to be able to enter Turkey: Ukraine.

A max. stay of 90 days is granted within a 180 day period to holders of normal passports issued to nationals of Ukraine.

Visitors exceeding the period for which they are allowed to stay must report to the immigration police and obtain a permit of residence ("Ikamet Vesikasi") which must be produced upon departure.

#### Certain Visa regulations apply as follows:

Visitors who require a visa and do not hold return/onward ticket could be refused entry .

### Health Turkey

This information is for guide purposes only. Other health organisations may recommend alternative precautions.

Vaccinations not required.

**The following Health and Vaccinations precautions are recommended:**

Malaria prophylaxis. Limited malaria risk - exclusively in the benign (*P. vivax*) form - exists from May to October incl. in the following provinces: Diyarbakir, Mardin and Sanliurfa. There is no malaria risk in the main tourist areas in the west and south-west of the country. Recommended prevention in risk areas: **II**.

**Visa Singapore**

Visa required.

**Passengers transiting only are exempt from holding a visa when:**

Nationals of Ukraine holding onward tickets for a max transit time of 96 hours under the Visa Free Transit Facility (VFTF). Leaving the transit area is allowed.

**The following should be taken into account even if holding a Visa:**

Hotel accommodation is available within the transit area of Singapore Changi Airport (SIN).

There are no international airside transfer facilities available between Singapore Changi (SIN) Terminals 1, 2 and 3 and the Budget Terminal. Passengers wishing to transfer between Terminals 1, 2 and 3 and the Budget Terminal must clear immigration, collect their baggage and clear customs before proceeding to the other terminal.

**Health Singapore**

Passengers arriving within 6 days after leaving or transiting countries with risk of yellow fever transmission and not holding a yellow fever vaccination certificate are subject to medical screening upon arrival. Entry could be refused.
